

## WILDLIFE REMINDER

Coyotes live in the preserve areas surrounding Placido Bayou and are often seen running down the street or standing in a yard. Leaving food outside invites not only coyotes, but other wildlife to your home. Please make sure you keep your small pets on a leash or indoors. ## **EYEONWATER APP**

Yes, you've heard it before but it's worth repeating. **The EyeOnWater app can save you money both from wasted water and damage to your home.** If you don't believe us, take it from a neighbor who recently experienced a hidden leak:


"Thanks for all of your help. Thought I would close the loop and let you know what happened. After a sleepless night of thinking I had a major slab leak problem, my leak detector man and my new plumber determined it was my RO filter! Suffice it to say, I dodged a bullet. Breathing easier. Water intrusion is crazy nerve wracking for the \$\$\$ it can chalk up. I paid \$300 for the leak detection and I'm so glad. I blew 2,700 gallons of water!

Additionally, I'm so curious if you know how Eye on Water works exactly. I have the app, but do they come and put a sensor near my meter? How do they know? Is this just a Pinellas program? I am spreading the word because they really saved me in the long run."

EyeonWater is included free of charge for every Placido Bayou resident living in a single-family home. The condo meters are monitored by the individual condo boards and managers. The app alerts you if a continuous flow of water is detected over a 24-hour period. If the limit is set low (1 gallon), as this owner's was, even the smallest of leaks can be stopped before major damage occurs.

To register, go to www.eyeonwater.com/signup and follow the directions. The service address is 33703 and your account ID is your house number followed by a hyphen and your neighborhood designation. It is NOT your Oates Energy account number. For example, the PBCA office is 4691-F. If you need help, Julia is just a phone call away.




